Chief provided copies of the training schedule for 2019 to the Commissioners.

Chief Wassall noted we applied for a Fire House Subs grant for replacement nozzles.

## Commissioner(s) Report

Commissioner *Noll* commented he was pleased about the funds that went into the reserve fund, and asked if there were policies related to the reserve account transactions. Chief McCollum said the County policy states it takes Commissioner action. It was discussed that PCFD13 should have a specific policy.

ACTION ITEM: Create a dept. policy to address approval for reserve fund large expenditures.

Commissioner <u>Zuluaga</u> talked about the Debt Planning information from Jim Blumenthal, Vice President with Martin Nelson and Company, and the cost of vehicle replacements. The document reviews how to finance apparatus replacement. Commissioner <u>Zuluaga</u> indicated that the amortization is normally 7 – 10 years and that we get the best interest rate available, approximately 3%. There was additional discussion on future needs based on double the call volume with the Town Center development: Fire & EMS vehicles, vehicle storage and possible building expansion to house an additional EMS vehicle.

Each year Pierce County Fire District 13 (PCFD13) volunteer firefighters/EMTs participate in the Scott Firefighter Stairclimb to raise funding for The Leukemia & Lymphoma Society. The climb is happening in March. The firefighters gear up and climb the stairs up to 788 feet of vertical elevation, 69 flights of stairs, with 1,356 steps. #### **OLD BUSINESS:**

1. Town Center development updates: Guests, Dennis Bryant, part owner of Living Care Lifestyles (operating under brand name Quail Park Communities) and Matt Herron, owner of the Town Center introduced themselves. They shared 2 different site plans. Once costed and more formal architectural plans are in place, they will return with more detailed plans. They stated they will not exceed the County's height restrictions and that they are limited to a certain number of dwelling units per acre. Commissioner Zuluaga shared the concern that the increase in call volume needs to be proportional to the revenue received by the Fire Department. The levy amount on the increased

assessed value of the Town Center will not be sufficient to cover staffing and equipment needs. A possible future contract for EMS services was discussed. Mr. Bryant shared that they deal with other volunteer fire departments and he will return with call information from their other facilities. He also stated that a successful Fire Department is important to them and their goals too, and said they want to cover their impact and offer community goodwill.

2. Billing for EMS transports: Chief McCollum shared the contract amendments received. There was discussion on size of newer equipment. Aid vehicles are getting larger. The Commissioners discussed the contract revisions and found them acceptable. Chief will check on whether we are still able to get a Medicare number for 2019, which is necessary for billing Medicare. We have the option to be able to waive a billing for certain situations.

ACTION ITEMS: Two resolutions will be needed at Feb. meeting.

**Motion-**A motion was made by Commissioner <u>Noll</u> to authorize Chief McCollum to establish an EMS billing policy and program for PCFD #13.

**Motion-**A motion was made by Commissioner <u>Malone</u> to sign a contract with Systems Design to move the EMS billing program forward.

**Motion-**A motion was made by Commissioner <u>Noll</u> to establish a checking account (First Citizens Bank) to correspond with our EMS billing.
