### **OLD BUSINESS:**

 Commissioner <u>Noll</u> wanted to know if there were updates with Systems Design for EMS billing. Chief McCollum is examining the process and use of the system to ensure we are ready to use the system effectively. This will be addressed in the March Fire Commissioner's Meeting.

## **NEW BUSINESS:**

- 1) Safety Committee (What do they do?). Per Chief McCollum the fire district is required to have a safety committee per Washington State Department of Labor & Industries and they are required to meet quarterly. The committee will focus on safety related issues and put forth recommendations for safety change.
- 2) Impact from WA State Measles Outbreak. Commissioner <u>Noll</u> wants to know how PCFD13 EMS personnel would respond to a patient with measles. Fire Chief confirmed that EMTs are required to be vaccinated to volunteer or work in the state and there are protocols fore protecting personnel on all calls.

- 3) Commissioner *Noll* had three points of interest for consideration:
  - A. Recommended viewing the Washington Fire Chiefs website at washingtonfirechiefs.com as a source of excellent overall information, including a weekly summary of fire related Washington state legislation in process. The Fire Chiefs priorities and top 5 issues relate to:
    - Sustainable Funding (restructure 1% levy lid cap, EMS Cap increase to .75)
    - Fire training academy funding
    - Improve volunteer fire fighter pension
    - incentivize regionalization

- B. There is potential for a fire district to 'annex' islands of property within the district that do not contribute any property tax money yet there still receive coverage from the fire department. Cliff mentioned that there is potentially one such property within the district.
- C. There is a bill (HB 1670) which would increase bid limits for equipment and public works. The bid limit for equipment would increase from \$10k to \$40k without having to go out for bids. The bid limit on facility construction would increase from \$20k to \$30k.
